Mutuse is a trader dealing with fresh fruits and vegetables in Eastern Kenya, while Masumbuko transporters is an independent transport company that delivers goods on contract. On September 2021, Mutuse hired Masumbuko transporters to deliver three Lorries of bananas from Mwihoko to Salama some 850 kilometers away. One of the Lorries broke down at Mlolongo. Three days later the driver decided to sell the bananas which were now ripened and deteriorating to the locals. He received Ksh. 20,000 from the sale. Much of the bananas has been damaged and he received less than a quarter of the initial value. The driver informed his employer, Masumbuko what had happened who in turn wrote to Mutuse regarding what happened and what they were compelled to do. Mutuse traders disagreed with them and decided to take legal action against Masumbuko transporters.
