QUESTION ONE (30 MARKS)

a) Explain the meaning of the following terms

b) Maguna supermarkets has many branches in Central Kenya. Discuss the control systems required to be put in place by a head office in relation to the branches? (5 marks)

c) Kahawa Ltd has an authorized nominal capital of Shs200, 000 ordinary shares of Shs10 par value each. The whole capital was issued on the following terms

On application 2.00

On allotment 6.50 including premium

First call 2.50 Second and final call 3.00

Applications were received for 330,000 shares. An applicant for 30000 shares was rejected and monies refunded. The Directors decided to allot the balance of the shares on the basis of two for every three applied for. The balance of application monies was to be applied to the allotment. Applicants paid the allotment monies as expected. Other calls were made and paid for in full with the exception of a member who failed to pay for the first and the second call on the 1500 shares allotted to him. A resolution was made by the directors to forfeit the shares. The shares were later issued to another person at Shs8 per share fully paid.

On 30/6/2019 materials at site were valued at sh. 2,100,300. On the same day outstanding wages were sh. 350,000 and subcontract work sh. 25,000. The company received sh. 36,000,000 from the contractee which represents work certified as at 30/6/2019 after deducting 15% retention money. It is estimated that work costing sh.360, 000 is not covered by the certificate. The plant and machinery specifically purchased for the project is to be depreciated at 20% straight line with no residual value.
