## **QUESTION ONE (30 MARKS)**

Dispute over the tender for printing the presidential ballot paper is awaiting determination by the court of appeal. Printing for the paper ought to have according to the commission time table. The Kenya Kwanza Alliance has objected to the paper printing and publishing, claiming it the company is close to the Azimio Coalition party.

Ballot paper for governor, senator, members of the national assembly, women representatives and ward representatives were not disputed and were therefore unaffected by the high court ruling, which stopped the printing of the presidential papers on the basis that the tender was awarded to Single Firm without public participation.

IEBC has since appealed the ruling on the grounds that the court directive was not practical, more so with the limited time left until August 9th election day ....... On the presidential ballot paper, crisis, Mr. Chebukati said the commission is considering direct procurement should the court not rule in its favour...... "There are conditions that justify that process. We have explored options and we have a basis as to where we could go when it comes to direct procurement. We can justify the identification of the company" (Daily Nation, pg4cl1-4-Report by Walter Menya, Kennedy Kimathi & Maureen Kakai).
