CASE STUDY

ECONOMIC DEVELOPMENT SOCIAL WELFARE.

After the last year's election in South Africa, ZANU PF a political party that has been in power for the last two decades won the election but not with a big margin unlike in other elections. Despite the win, the electorate who majority were young people aged between 18 and 35 were not happy with the leadership of ZANU and this was evident the way their votes were divided to other minority parties. One of the major issues raised by the youth was unemployment. This is because in south Africa despite high education attainment rates among the youth, majority of the youth lack formal employment. Majority of the people involved in informal employment in south Africa are youth aged between 18 and 35 years, accounting for the 60% of the total population involved in the informal sector. One aspect which is evident is that South Africa has been underperforming in terms of economic growth and development which has led to majority of the citizens experiencing socio economic challenges.

Other sectors that have been greatly affected are health and education with those affected majorly living in the rural areas and in the informal settlements in urban areas. This is despite empirical studies showing the importance of these two sectors towards human development. During campaign period, one of the key aspects challenged by the opposition was the foreign trade policy of South Africa, where the argument was based on unfavourable conditions for foreign investors due to hostility to foreigners through xenophobia. The opposition were promising that when the get to power, they shall promote foreign trade and investment through policies that encourage free trade and liberalization. The election results were a wakeup call to the ruling party that among other things, they need to create formal employment for the youth or create more favourable conditions for the informal employment.
