### CONFLICT OF INTEREST

Recently, Oliver was hired by a small, private hospital. The hospital was interested in upgrading the hardware and software it uses for patient records and accounting. The hospital had already solicited proposals for upgrading their system. They hired Oliver to evaluate the proposal they had received. Oliver examined the proposals very carefully. He considered which system would best meet the hospital's needs, which company offered the best services in terms of training of staff and future updates, which offered the best price, and so on. He concluded that Tri-Star Systems was the best alternative for the hospital, and he recommended this in his report, explaining his reasons for drawing this conclusion. What Oliver failed to mention (at any time in his dealings with the hospital) was that he is a silent partner (a coowner) in Tri-Star Systems.
