### A case study of the Greater Horn of Africa and its ills

The Greater Horn of Africa has been in the news for more than ten years as one of the areas in the globe most affected by numerous humanitarian crises. This region is known for its food insecurity, environmental degradation, human insecurity, natural and man-made disasters, poor health, and harmful, outdated cultural practices. Poverty, illiteracy, and ignorance are also commonplace. Over 40% of the population in the region suffers from malnutrition, with the percentage rising to 70% in Eritrea and Somalia (WFP & FAO, 2022). According to FAO, there are 160 million people living in the seven nations in the region (Djibouti, Ethiopia, Eritrea, Kenya, Somalia, Sudan, and Uganda), 70 million of them are prone to severe food shortages.

These nations, who are all part of the Intergovernmental Authority on Development (IGAD), have had famine threats at least once every ten years for the previous thirty years. The region's planetary health is not in good shape. Despite its little emissions to the environment, the region paradoxically and ironically suffers the brunt of the planetary health problem brought on by climate change. There is a plethora of additional issues in this region that also fit the requirements to be considered of community concerns.
